The Undersigned hereby certifies that he, on behalf of NEWMONT GOLD COMPANY, a Delaware corporation, has caused to be located the MOLE 4 Lode Mining Claim in the following Quarter Section(s): SE¼ of Section 11 and NE¼ of Section 14, Township 35 North, Range 50 East, M.D.M., in Eureka County, Nevada, on the 21st day of January, 1993 at 11:15 O'Clock A.M.

The Claim is approximately 1500 feet long and 600 feet wide, such that 1400 feet is claimed in a NORTHERLY direction and 100 feet in a SOUTHERLY direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

| No. 6: WS Center | WC-WS Center - MOLE 4 | 4" X 4" WOOD POST |

As erected on the ground, each side center or corner monument is marked as described above by marked aluminum tag. The above indicated witness corners (WC) are particularly depicted on the Claim map. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
