The Undersigned hereby certifies that he, on behalf of NEWMONT GOLD COMPANY, a Delaware corporation, has caused to be located the **MOLE 7** Lode Mining Claim in the following Quarter Section(s): SW¼ of Section 11 and NW¼ of Section 14, Township 35 North, Range 50 East, M.D.M., in Eureka County, Nevada, on the 21st day of January, 1993 at 10:15 O'Clock A.M.

The Claim is approximately 1500 feet long and 600 feet wide, such that 600 feet is claimed in a NORTHERLY direction and 900 feet in a SOUTHERLY direction from the witnessed point of discovery (witnessed monument of location), and the Notice of Location was posted at the witness location monument on the Mole 6 claim, (which is also the location monument of the Mole 6 claim), together with 300 feet on each side of the true position of the monument of location and center line of the Claim. The general course of the lode or vein is from the North to the South direction.

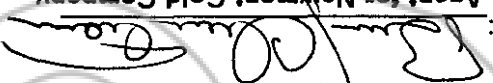
The number, location and markings on each side center or corner monument is as follows:

No. 1: NW Corner	NW Corner - MOLE 7	4" X 4" WOOD POST
No. 2: NE Corner	NE Corner - MOLE 7	4" X 4" WOOD POST
No. 3: ES Center	WC-ES Center - MOLE 7	4" X 4" WOOD POST
No. 4: SE Corner	WC-SE Corner - MOLE 7	4" X 4" WOOD POST
No. 5: SW Corner	WC-SW Corner - MOLE 7	4" X 4" WOOD POST
No. 6: WS Center	WC-WS Center - MOLE 7	4" X 4" WOOD POST

As erected on the ground, each side center or corner monument is marked as described above by marked aluminum tag. The above described witness corners (WC) and the witnessed monument of location are particularly depicted on the Claim map.

The work of location consisted of making a claim map as provided in N.R.S. 517.040.
