The Claim is approximately 1500 feet long and 600 feet wide, such that 750 feet is claimed in an Easterly direction and 750 feet in a Westerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the East to the West direction.

As erected on the ground, each side center or corner monument is marked as described above by marked aluminum tag. The above indicated witness corners (WC) are particularly depicted on the Claim map. The work of location consisted of making a claim map as provided in N.R.S. 517.040.
