The Claim is approximately 1500 feet long and 200 feet wide, such that 1100 feet is claimed in an EASTERLY direction and 400 feet in a WESTERLY direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 100 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the East to the West direction.

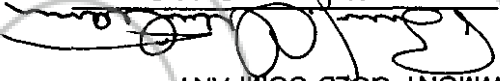
The number, location and markings on each side center or corner monument is as follows:

No. 2: NS Center	NS Center - MOLE 11	4" X 4" WOOD POST
No. 3: NE Corner	NE Corner - MOLE 11	4" X 4" WOOD POST
No. 4: SE Corner	SE Corner - MOLE 11	4" X 4" WOOD POST
No. 5: SS Center	WC-SS Center - MOLE 11	4" X 4" WOOD POST
No. 6: SW Corner	SW Corner - MOLE 11	4" X 4" WOOD POST

As erected on the ground, each side center or corner monument is marked as described above by marked aluminum tag. The above indicated witness corner (WC) is particularly depicted on the claim map.

The work of location consisted of making a claim map as provided in N.R.S. 517.040.
