6. Claimant has made repeated demands for the aforesaid

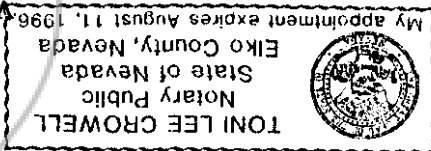
