

SPECIAL WARRANTY DEED
CONVEYING OVERRIDING ROYALTY INTEREST

This Special Warranty Deed (this "Deed") is made this 30th

day of June, 1993 from PLACER DOME U.S. INC., a California

corporation, with principal offices at Suite 2500, One California

Street, San Francisco, CA 94111 ("PDUS"), CORTEZ JOINT VENTURE

and CORTEZ GOLD MINES, each being a joint venture composed of

PDUS and Kennecott Explorations (Australia), Ltd., as joint

venturers, (the three foregoing parties are hereinafter referred

to collectively as the "grantors") and W.L. WILSON, whose address

is P.O. Box 2183, Grand Junction, CO 81502; JOAN B. WILSON, whose

address is P.O. Box 2183, Grand Junction, CO 81502; WILLIAM G.

WALDECK, whose address is P.O. Box 2188, Grand Junction, CO

81502; JOANN K. WILSON, TRUSTEE of the JOANN K. WILSON 1988

TRUST, whose address is 1125 Dartmouth Drive, Reno, NV 89509;

H.B. SPRENGER and BETTY SPRENGER, husband and wife, whose address

is 2541 Lakeridge Shores Circle, Reno, NV 89509; and DENVER G.

CHEERY, TRUSTEE of the CORTEZ INTEREST TRUST, whose address is

2135 North 7th Street, Grand Junction, CO 81501. (The foregoing

seven parties are referred to collectively as the "grantees.")

I.

Conveyance of Overriding Royalty Interest

1.1 The grantors, for and in consideration of Ten Dollars

(\$10) and other valuable consideration received from grantees,

the receipt and sufficiency of which is acknowledged, hereby

bargain, sell, deed and convey to grantees, their successors,

personal representatives, heirs and assigns, a perpetual overriding royalty interest (the "Royalty") as specified below, in mining claims, mineral properties and interests therein presently owned, leased or otherwise held by grantors, or which may hereafter be acquired by grantors, within the "Area of Interest" in Lander and Eureka Counties, Nevada, all as more fully described in this Deed, and which are referred to hereinafter as the "Subject Property".

1.2 The rights, interests and the total of the Royalty conveyed under this Deed is conveyed in the respective undivided percentage to the individual grantees, their successors, personal representatives, heirs and assigns, as set forth in the following tabulation:

Percentage, Royalty Bases, and Method of Calculation of Royalty

2.1 Percentage of Royalty. Under and by virtue of the

Royalty hereby conveyed grantees, grantors shall pay to grantees in the proportions of the undivided ownership of each as set

forth in paragraph 1.2, above, an overriding royalty (or shall

deliver to each grantee his or her share of mineral product if

grantees have elected to take their Royalty in kind) equal to the

percentages set forth below, with respect to all gold, silver,

and other salable ores metals, minerals, materials and other mine

or mill product (referred to, collectively, as "production")

produced from the Subject Property on or after October 1, 1993,

in accordance with the provisions hereinafter set forth. The

percentage rate of the Royalty shall be two and one-half (2.5%)

and calculation of the overriding Royalty shall be accomplished

by multiplication of the royalty percentage by the applicable

royalty base (the "Royalty Base") (or by the weights of salable

production, in respect to Royalty taken in kind) all in the

manner and in accordance with the provisions set forth in this

Article II.

2.1(a) Gold and/or Silver: The Royalty Base applicable to

gold or silver produced from the Subject Property, other than

gold or silver contained in ores or concentrate which are subject

to 2.1(b), below, shall be the "Gross Value", calculated as

hereinbelow specified, whether produced by in situ or solution

mining, by mining ores and the extraction of gold or silver by

means of heap or vat leaching, by milling or other extraction

method and by refining to produce "Bullion". The term "Bullion", as used herein, means refined gold or silver meeting the

generally accepted commercial standards for refined gold or

refined silver, as the case may be, recovered from production by

refining by an independent third-party refinery or refineries.

The number of ounces (wherever used herein "ounces" refers to

Troy ounces) of gold or silver contained in Bullion recovered in

each month from production shall be determined by the records

pertaining thereto of the said refinery or refineries.

2.1(a)(1) Calculation of "Gross Value". "Gross Value" as

used in this section 2.1(a) shall be determined by multiplying

the ounces of gold and of silver contained in Bullion recovered

during any calendar month, by the respective average price for

gold and silver Bullion for that month, as follows:

(i) The average monthly price of gold for the month of

production shall be calculated by dividing the sum of all of

the prices for gold reported for the month by the London

Bullion market Association in its P.M. Gold Fixes divided by

the number of days for which such prices were reported.

(ii) The average monthly price for silver for the month

of production shall be determined by the average New York

Silver Price as published daily by Handy and Harman,

calculated by dividing the sum of all such prices reported for

the month by the number of days for which such prices were

reported.

(iii) If either the London Bullion Market Association

P.M. Gold Fix or the Handy & Harman silver quotations cease to

be published, all such references shall be replaced with

references to prices of gold or silver for immediate delivery

in the most nearly comparable established market selected by

grantors as published in "Metals Week" or a similar

publication.

2.1(a)(2) Gross Value Royalty Base. The product obtained by multiplying the number of ounces of gold contained in Bullion

recovered during any month by the average monthly price for gold Bullion for such month (as such average monthly price is

determined as above provided), shall be added to the product obtained by multiplying the number of ounces of silver contained

in silver Bullion recovered during that month by the average monthly price for silver for such month, (as such average monthly

price is determined as above provided), and the sum of those amounts shall constitute the Gross Value Royalty Base for

calculation of gold/silver Royalty applicable to this section 2.1(a) due for that month.

2.1(a)(3) Right to Take in Kind. Waldeck and/or the other Grantees as a group may elect to receive their gold/silver

Royalty in kind by physical delivery of gold and/or silver Bullion for any calendar year, by notifying grantors of their

election on or before December 1 in the preceding calendar year. An election by Grantees to receive the Royalty in kind shall be

irrevocable for the calendar year for which it is made. Failure of Waldeck or the other Grantees to notify Grantors by December 1

of their election to take the Royalty in kind, shall be deemed a waiver by him or them of all rights to take the Royalty in kind

during the following calendar year. If Waldeck or the other Grantees elect to take in kind, the amount of Bullion delivered

to Grantees shall be equivalent to the applicable percentage of the Royalty Rate, as specified above multiplied by the ounces of

gold and/or silver recovered from the Subject Property attributable to the applicable calendar month. On or before the last day of the month following the end of each calendar month, Grantors shall make the Bullion available to Waldeck and/or the other grantees at the place where the Bullion has been refined. The Bullion shall be in the form in which Grantors sell or otherwise dispose of same. Grantors shall provide ten (10) days' prior notice to Waldeck and/or the other grantees of the name and location of the refinery and the date or dates on which the Bullion will be available to him and/or them.

2.1(b) Ore or Concentrate Sold to Smelter: The Royalty Base

for calculation of Royalty in respect to ore produced from the Subject Property and/or concentrate derived from ores produced from the Subject Property (other than ore principally valuable for the uranium and/or vanadium content thereof) which are sold in an arms-length sale to a third-party smelter by Grantors shall be the Net Smelter Returns received therefrom. The term "Net Smelter Returns" means the amount actually received by Grantors from the Smelter less, (i) the costs of surface transportation, inclusive of insurance, of the ores from the Subject Property (in the case of ores sold in the crude state) or of the concentrates from the mill (in the case of the sale of concentrate derived from such ores) to the smelter, to the extent that such costs are paid by Grantors, (ii) the costs of smelting such ores or concentrates if paid by Grantors and (iii) any metallurgical

penalties, surcharges or other charges made or imposed by the smelter to the extent the same are paid by grantors.

2.1(c) Uranium and/or Vanadium Ore: The Royalty Base for

calculation of Royalty in respect to ore principally valuable for uranium and/or vanadium which is mined and sold from the subject Property, if such ore is sold in the crude state in an

arms-length sale, shall be the Net Sales Price received therefor. "Net Sales Price" shall mean the proceeds received from the sale of such ore less the costs of surface transportation, including insurance, of the ore from the Subject Property to the point of sale. If such ore is concentrated by grantors, either in its own facilities or by means of tolling arrangements, or if such ores are sold other than as a result of an arms-length transaction, then the term "Net Sales Price" shall mean the prevailing price paid at the time such ore is mined for ores of like grade and metallurgical characteristics f.o.b. the Subject Property by other purchases of uranium and/or vanadium ores.

2.1(d) Other Mineral, Substances and Ores: If grantors should

produce and sell any minerals, substances or ores from the subject Property, other than those encompassed within the provisions of subparagraphs (a) through (c) above, the Royalty Base for calculation of the Royalty applicable thereto shall be the net proceeds received for such substances after deducting the cost of the transportation thereof from the Subject Property to the point of sale.

2.2 Effect of Imposition of Federal Royalty: Net Proceeds of

Mines Taxes: If, in the future, a royalty is imposed on, and required to be paid upon production from, mining claims by the United States of America, the amount of such royalty actually paid to the United States by grantors may be deducted by grantors from the applicable Royalty Base before calculation of the Royalty payable in respect to Production from claims burdened by such United States royalty. Grantees shall be responsible for payment of any Net Proceeds of Mines taxes imposed by the state of Nevada in respect to Royalty paid under this Deed.

2.3 Commingleing of Ores. At no time shall ores, minerals or materials produced from properties outside of the Area of

Interest (defined in Sections 3.2 and 3.3, below) be commingled with Production derived from properties within the Area of Interest, except and unless all such commingled ores, minerals and materials comprising Production from each source have first been weighted or measured, sampled, assayed and metallurgically analyzed in accordance with sound mining and metallurgical practice in order that the Royalty due Grantees hereunder can be reasonably and accurately determined. Upon request to Grantors, Grantees shall have the right to have a representative present at the time all such samples and measurements are taken. Grantees shall have the right to obtain sample splits for separate assaying in order to determine the accuracy of the assays of Grantors. Grantors shall make available to Grantees pertinent technical data and records within its possession reasonably

required to determine the accuracy of calculation made by grantors of Royalty payable upon commingled ores, minerals or materials.

2.4 Furnishing Marketing Information. Grantees shall have

the right to be supplied monthly with duplicate settlement sheets from any refinery, mill, smelter or other purchaser of production derived from the subject property, whether or not the mine products have been sold, and shall be supplied with grantors' monthly reports of mining, milling and leaching activities and sufficient information as to the amounts of the gold and silver contained in dore and Bullion recovered during the month so that grantee will be able to determine the amount of production on which Royalty is due grantees.

2.5 Payment of Royalty. Payments of Royalty shall be made by

check or wire transfer, at the election of grantees. Payments of Royalty attributable to the undivided seven percent (7%) owned by grantee, William G. Waldeck, ("Waldeck") shall be made to Waldeck, his personal representatives, heirs or assigns,

provided, however, that, if the interest of Waldeck should become vested in more than one person or entity, then grantors may

require that such persons and/or entities appoint a bank as a depository and agent for receipt of payment in order that payment of Waldeck's share of the Royalty may continue to be made to a

single person or entity. Payments of Royalty attributable to the grantees other than Waldeck (being 93% of the total Royalty)

shall be made to the Depository and Agent for Receipt of Payment

designed in paragraph 2.6, below. Royalty on Production shall be payable monthly by the last day of the month following the month in which settlement is made. Grantors shall accompany each such payment with sufficient detailed data showing quantities of Production produced and refined, in respect to gold or silver, or sold in respect to other types of Production, in order that grantees may verify the accuracy of each payment.

2.6 Depository Agent. The Grand Valley National Bank, P.O. Box 4090, Grand Junction, CO 81502, (the "Depository Agent") is hereby designated by grantees other than Waldeck as their agent to receive and distribute Royalty payments which become due grantees. Payments of Royalty by grantors to Depository Agent shall constitute full payment to grantees, and grantors shall have no responsibility for the subsequent distribution from the Depository Agent to the individual grantees. The Depository Agent may be changed, from time to time, by written notice from grantees other than Waldeck to grantors.

III.

Subject Property

3.1 Properties and Interests Presently owned or Held By

Grantor. The mining claims, properties and interests therein presently owned or held by grantors which are subject to the Royalty and rights and interests conveyed to grantees under this Deed, are specifically listed and described on Schedule I and II, hereto attached and incorporated herein by this reference for all purposes. If Grantor presently owns mining claims, properties

and/or mineral interests within the Areas of Interest which are not described on Schedules I and II, such mining claims, properties and/or mineral interests shall nevertheless be a part of the Subject Property and the payment of overriding Royalty under this deed.

3.2 Area of Interest. If grantors should amend, relocate or patent any of the mining claims which are or which may become subject to this Deed, or if grantor should acquire any mineral interests within the hereinbelow described areas (the "Areas of Interest"), any such amended, relocated or patented claim or newly acquired mineral interest shall be considered for all purposes, to be a part of the Subject Property, subject to all of the terms and conditions of this Deed, including the obligation to pay grantee the Royalty thereon as specified in Article II hereof.

3.2(a) Initial Area of Interest: The "Initial Area of Interest" (which is the same area of interest to which the Cortez joint venture is subject) is described as:

Beginning at a point which is described as 40°00', North Latitude, 116°30', West Longitude (which point is also the southeast corner of the Cortez 15' Quadrangle map published by the U.S. Geological Survey (USGS));

thence west along a line which is 40°00', North Latitude to a point which is described as 40°00', North Latitude, 116°45', West Longitude, which point is also the southwest corner of the aforementioned Cortez 15' Quadrangle;

thence north along a line which is 116.00', west Longitude to a point which is described as 40.10' North Latitude, 116.45' west Longitude;

thence west along a line which is 40.10' North Latitude to a point which is 40.10' North Latitude, 117.00' west Longitude;

thence north along a line which is described as 117.00' west Longitude to a point which is 40.30' North Latitude, 117.00' west Longitude, which point is also the northwest corner of the Mt. Lewis 15' Quadrangle, published by the USGS;

thence east along a line which is 40.30' North Latitude to a point which is described as 40.30' North Latitude, 116.40' west Longitude;

thence south along a line which is 116.40' west Longitude to a point which is described as 40.15' North Latitude, 116.40' west Longitude;

thence east along a line which is 40.15' North Latitude to a point which is described as 40.15' North Latitude, 116.30' west Longitude, which point is also the northeast corner of the said USGS Cortez 15' Quadrangle;

thence south along a line which is 116.30' west Longitude to the point of beginning, which is 40.00' North Latitude, 116.30' west Longitude, and which is the southeast corner of the said Cortez 15' Quadrangle.

In addition to the above described area, the Initial Area of Interest shall include that area in Eureka County, Nevada, the

exterior boundary of which is the circumference of a circle

having a radius of two and one-half (2-1/2) miles and which has its center at U.S.L.M. Number 228, Eureka County, Nevada.

The Initial Area of Interest includes the entire Cortez and

Mt. Lewis 15' quadrangles, as well as the described portions of

the Crescent Valley, Carico Lake and Home Creek Valley 15'

quadrangles, and is within Lander and Eureka Counties Nevada.

3.2(b) Additional Areas of Interest. In addition to the area

described above, the following properties and areas are outside

the boundaries of the area described above, but are held by or

for the account of grantors, and are subject to the obligation of

grantors to pay to grantees the same royalty as would be

applicable if such properties were within the area described in

3.2, above:

A. That portion of the Mule Group of claims which is

outside the boundaries of the area described above. These claims

are within Section 36, T.28N., R.48E., and Section 6, T.27N.,

R.49E., MDB&M.

B. That portion of the GRM Group which are subject to the

Prospecting Permit and Purchase Option Agreement dated August 13,

1991 between PDUS and Gold Fields Mining Company, and which are

situate outside the boundaries of the area described above.

These claims are situate Sections 1, 2, 3, 10, 11, 12, 13, 14,

15, 22, 23, 27 and 34, T.28N., R.47E., MDB&M.

3.3 Obligation of grantees in Respect To Mineral Interests

Acquired Within Areas of Interest. For a period of twenty (20)

years from and after the date of this Deed, none of the grantees shall seek to, nor, acquire any rights and interest in mining properties within the Areas of Interest without obtaining the prior written permission of grantors to do so. Subsequent to the said 20 year period, and subject to the limitation of section 5.1, below, if any of the persons comprising grantees should

acquire any mineral interests within the Area of Interest, he or she shall, within 30 days of acquiring same, offer the interests so acquired to grantors. Grantors shall have a period of 45 days after receipt of such notice to elect to accept or reject such offer, and if it does not so notify the offering grantee within said 45 day period, it shall be deemed to have rejected the

offer. If grantors elect to accept the mineral interests it shall reimburse grantee for the direct costs of acquisition and grantee shall convey such title as it acquired in the mineral interests by special warranty deed, and said acquired mineral interests shall be and become a part of the subject Property

grantee shall convey such title as it acquired in the mineral interests by special warranty deed, and said acquired mineral interests shall be and become a part of the Subject Property subject to the Royalty and appurtenant rights and interests granted grantees hereunder.

3.4 Effect of Loss of Gold Fields' Claims. The mining claims listed in Part III.(x) of Schedule I and in Section A of schedule II hereto, record title to which is held by Gold Fields Mining Company ("Gold Fields") subject to the rights and interests of grantors under a Prospecting Permit and option to purchase Agreement dated August 13, 1991 between Gold Fields and PDUS (the "Option") are referred to in this paragraph 3.4 as the "Gold Fields claims." Although PDUS has notified Gold Fields of exercise of the option and tendered the balance of the purchase price for the gold Fields claims, Gold Fields has not, as yet, accepted the payment and litigation is now pending in which gold Fields may seek to contest PDUS's right to acquire the gold Fields claims. Notwithstanding any provision to the contrary herein contained, if PDUS and/or Cortez is unable to acquire the right to mine the gold field claims, such claims shall be excluded from the Subject Property, the Pipeline Claims and the Pipeline Area and shall not be subject to the Royalty and other rights and interest conveyed to grantees under this Deed.

(which may be conditioned upon the performance of usual and customary "due diligence" by the offering third party), the offering grantee shall first offer the interest to be sold to grantors by written notice specifying the name of the prospective purchaser, the portion of the interest to be sold and the price (which in any event must be a monetary amount) and the terms of payment of the purchase price. Within 30 days of the date of said notice, grantors may notify the offering grantee of grantors' election to purchase the offered interest at a price equal to the price and payment terms offered by the offering third party plus a premium ("premium") calculated as specified below. The premium shall be \$150,000 if 100% of the interests of grantees in the subject property is being sold, and, in direct proportion, less if a smaller percentage than 100% is being sold. (For example, if 10% of the entire interest of all grantees is being sold, the premium would be \$15,000.) If grantors fail, within the said 30-day period, to agree to purchase the interest offered, then at the end of the period the offering grantee may proceed with the sale to the offering third party at the price and in accordance with the terms contained in the said notice given to grantors, provided that the closing of the sale to the third party shall be made within 120 days of the end of the 30-day period specified above, or the sale shall become void and grantor's first refusal rights shall be reinstated. If grantors agree to purchase the offered interest, in the manner above provided, a closing of the sale to the grantors shall be held

within 30 days thereafter. The rights and obligations contained in this paragraph 4.1 shall expire and terminate twenty-one (21) years after the death of W.L. Wilson, one of the grantees herein. 4.2 Circumstances Excluded From Right of First Refusal. The right of refusal granted by paragraph 4.1, above, shall not apply to nor restrict any of the following:

(a) The mortgaging or encumbering of a grantee's interest as collateral for loans nor to a foreclosure sale which might result therefrom;

(b) Gifts made by a grantee without monetary consideration;

(c) Transfers made by a grantee to his or her spouse, child (inclusive of a step or adopted child), brother, sister or to another of the grantees;

(d) Transfers made to trusts or from trusts to the beneficiaries thereunder nor to transfers resulting from the death of a grantee whether testamentary or by intestate descent and distribution;

(e) Transfers by a grantee to a corporation or partnership in which the grantee or grantee and/or his spouse own a majority of the issued stock or in which the grantee or his spouse is a general partner; and

(f) Transfers made to PDUS and/or Kennecott.

Transferees under this Section 4.2 shall be subject to the provisions of Section 4.1.

4.3 Abandonment of Claims. Subject to the limitation of

Section 5.1, below, if grantors should elect to either cease

performing annual assessment work or pay holding fees in lieu

thereof or otherwise abandon any mining claims of the subject

property, and if neither of the individual joint ventures of

Cortez elect to obtain a conveyance of such mining claims,

grantors will first offer in writing sixty (60) days before

assessment work or payment of holding fees in lieu thereof which

become due on such claims, to quit claim any of its interests

therein to Idaho Resources Corporation, a corporation in which

all outstanding stock is presently owned by grantees. If Idaho

Resources Corporation notifies grantors in writing within 30 days

after receipt of any such offer, grantors shall execute and

deliver a quit claim deed, without any warranties of title, quit

claiming to Idaho Resources Corporation grantors, rights and

interests in the claim(s) elected to be abandoned by grantors.

V.

Miscellaneous

5.1 Limitations Under Rule Against Perpetuities. The rights

conferred and the obligations imposed by Sections 3.4 and 4.3,

above, shall terminate twenty-one (21) years after the death of

the survivor of W.L. Wilson, Joan B. Wilson, and their presently

living children, Suzanne Kelly Wilson, William Brent Wilson,

Juliet Ross Wilson and Hollis Carolyn Wilson.

5.2 Notices. All notices which may be made under the

provisions of this Deed shall be in writing and, at the election

of the party giving the notice, may be sent by facsimile transmission ("Fax"), the notice shall be deemed effective on the first business day following the date the fax was transmitted and the confirming copy thereof was placed in the United State mail. If notice is given by mail only, the notice shall be deemed effective 48 hours after it was placed in the United States mail. Either a confirming copy of a notice transmitted by fax or a copy sent by mail only shall be sent by first class registered or certified U.S. Mail in a properly addressed and stamped envelope with return receipt requested. Grantors may change the address(es) and/or the Fax numbers to which or persons to whose attention notices are required to be given by written notices to the other parties designated above, and grantees, and/or Idaho Resources Corp., in like manner, may change the address(es) and/or Fax numbers to which or person to whom notices shall be given, by giving written notice of such change to Grantors.

5.3 Binding Effect and Benefit. The provisions of this Deed shall be binding upon and inure to the benefit of the Grantors and grantees and their respective successors, personal representatives, heirs and assigns.

5.4 After Acquired Title, Further Assurances. The Royalty and other rights and interests conveyed to grantees hereby shall attach and appertain to all of the mining claims, mineral rights, properties, leases or interests therein described in Schedules I and II and also to any other mining claims or mineral rights,
