David R. Faley, first being duly sworn, deposes and says:

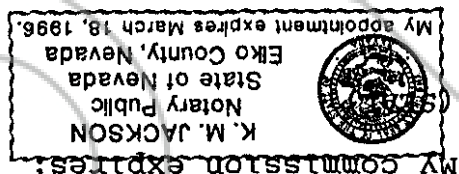
