

Certificate of Location of Lode Mining Claim

The general course of the lode deposit and premises is from the North to the South.
The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Metal tags on 2" x 2" x 4" wooden posts.
