

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Duck Camp Lode Mining Claim in Section 12, Township 31 N, Range W8 E in the Blaine Mining District, in Eureka County, in the State of Nevada, on the 17 day of Sept, 1993.

The claim is 1500 feet long and 600 feet wide, and 950 feet is claimed in a North direction and 150 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 30 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Scrub on wood (Describe method of marking, such as "scribing the wood")
