

Certificate of Location of Lode Mining Claim

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Dub, Sam Lode Mining Claim in Section 12, Township 31 N, Range 48 E in the Beware Mining District, in Eureka County, in the State of Nevada, on the 17 day of Sept, 1913.

The claim is 1500 feet long and 1000 feet wide, and 150 feet is claimed in a Northern direction and 750 feet in a Southern direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Scrubbing the wood.

NRS 517.300, Subsection 2.
