3. The owner of the claims listed on Exhibit "A-1" is Dave C. Mough whose address is P.O. Box 1937, Nevada City, California, 95959.

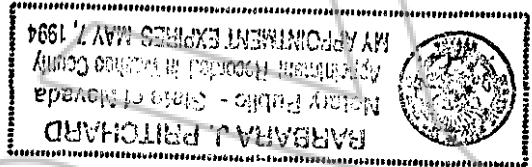

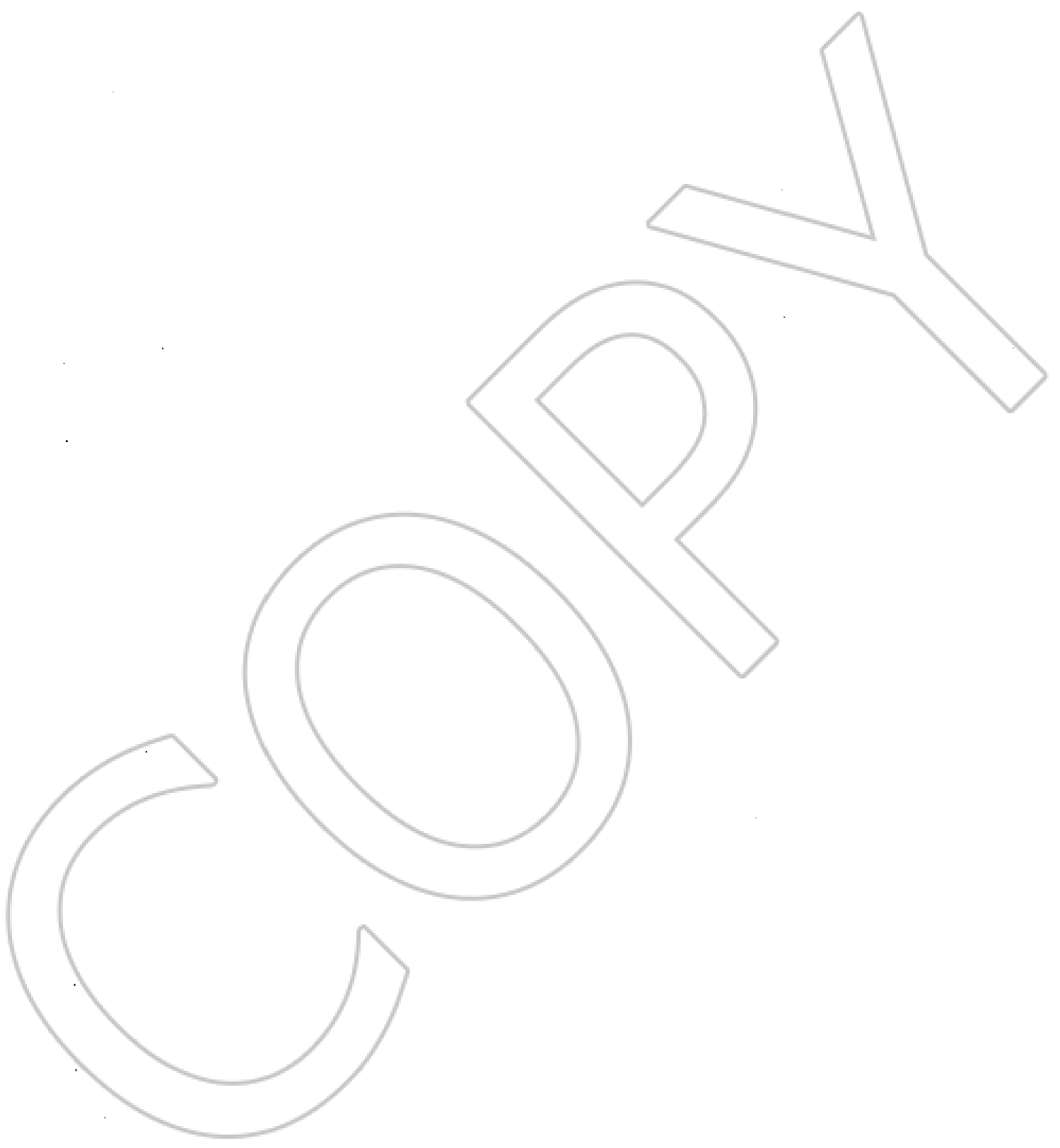
