CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the lode mining claim this 9th day of September 1993 under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 55° E direction and 1490 feet in a S 55° W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, Begin at the Northeast Corner, Section 28, T. 20 N., R. 52 E., Mt. Diablo P.M., and bear S 55° W 7030 feet, and S 35° E 26010 feet, to the northeast corner of this claim.

The location work consisted of making a mining claim map as provided in Nevada Revised Statutes 517.040. Two copies of the map are filed in the records of Eureka County, Nevada.

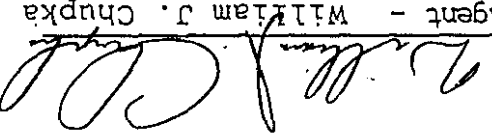
The location monument, corners and side centers are wood posts, set one foot in the ground or mound of stone. The location and markings on each corner or side center are more particularly described as follows:

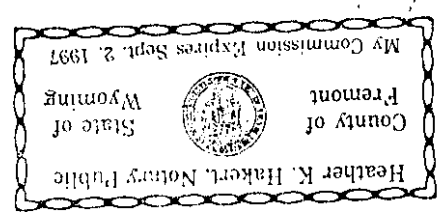
The monumentation and marking of the corners was completed by the 9th day of September, 1993
