MEMORANDUM OF AGREEMENT

NOTICE IS HEREBY GIVEN that LYLE F. CAMPBELL ("Campbell") acting individually and as Sole Trustee for THE LYLE F. 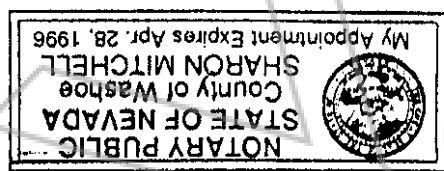

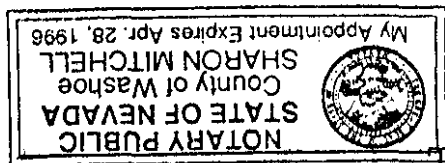

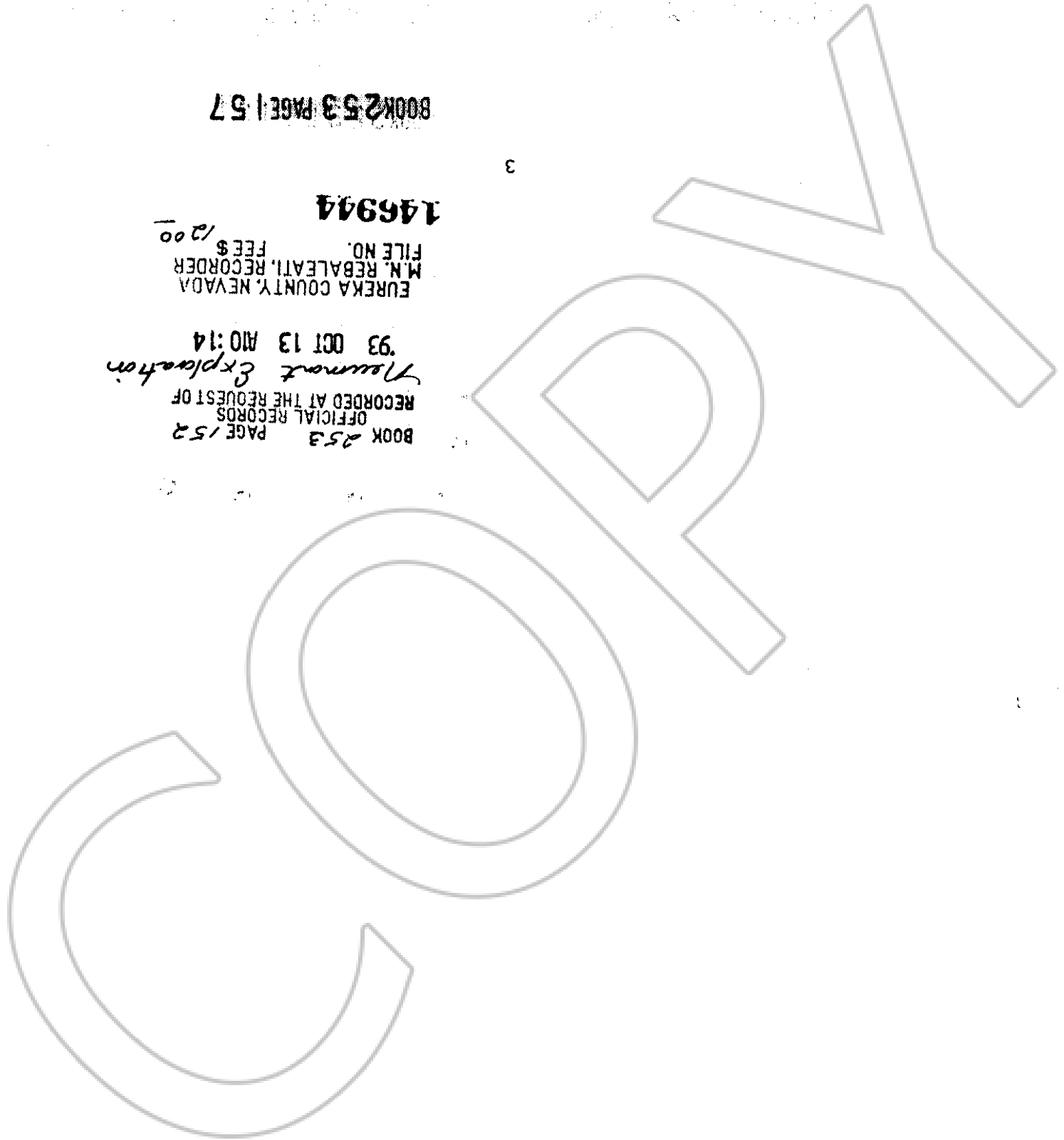
