

NOTICE OF NONRESPONSIBILITY FOR LABOR OR
MATERIALS FURNISHED MAGGIE CREEK MINERAL PROSPECT
(NRS 108.234)

Pursuant to NRS 108.234, notice is hereby given that Lyle F. Campbell ("Campbell") individually and as sole Trustee for The Lyle F. Campbell Trust (the "Trust") is the owner of the unpatented mining claims described in Exhibit "A" attached hereto with all improvements thereon. Such mining claims are now in the possession of Newmont Exploration Limited, a Delaware corporation, pursuant to an Exploration Agreement and Option to Purchase between Lyle F. Campbell ("Campbell") acting individually and as Sole Trustee for The Lyle F. Campbell Trust (the "Trust") and Newmont Exploration Limited, a Delaware corporation ("Newmont") executed the 11th day of October, 1993.

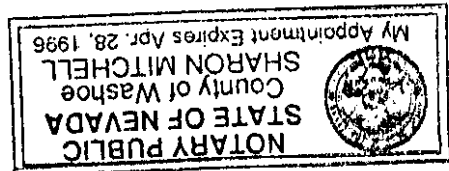

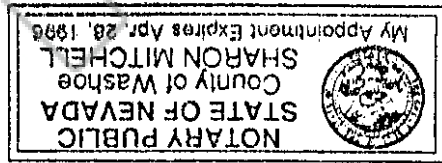
