1.3 This correction deed is made and executed to reflect corrections made in the June 30th 2.5% Royalty Deed by the correction 2.5% Royalty Deed, and in order to correct errors contained in, and furnish supplementation for omissions from the June 30th Partial Royalty Deed. The provisions of this correction deed shall supplement, supersede, and amend any applicable provisions contained in the June 30th Partial Royalty Deed. The portion and part of the two and one-half percent royalty acquired by grantors under the June 30th 2.5% Royalty Deed, as amended by the correction 2.5% Royalty Deed, conveyed under this correction deed is the same as, and is conveyed in lieu, place and stead of, the royalty conveyed by the June 30th Partial Royalty Deed and is not in addition thereto.

1.4 As used herein, "Cortez" refers to and means Cortez Joint Venture and Cortez Gold Mines, individually and collectively, being two joint ventures composed of PDUS and Kennecott, and the successors and assigns of said joint ventures.

II.

Conveyance of Interest in Overriding Royalty

2.1 The Grantors, for and in consideration of Ten Dollars (\$10) and other valuable consideration received from grantees, the receipt and sufficiency of which is acknowledged, in the place, stead and in lieu of, and not in addition to the overriding royalty conveyed to grantees by and under the June 30th Partial Royalty Deed, hereby bargain, sell, deed and convey to grantees, their successors, and assigns, a perpetual overriding royalty interest

(the "Overriding Royalty") as specified below, in mining claims, mineral properties and interests therein which are subject to the correction 2.5% Royalty Deed, or which may hereafter become subject to the correction 2.5% Royalty Deed, within the "Areas of Interest" in Lander and Eureka Counties, Nevada, all in the manner and as more fully specified and described in this Correction Deed, and which are referred to, hereinafter, as the "Subject Property".

2.2 The rights, interests and the total of the Overriding Royalty conveyed under this correction Deed is conveyed in the respective undivided percentage to the grantees, their successors and assigns, as set forth in the following

III.

Percentage, Royalty Bases, and Method of Calculation of Overriding Royalty

3.1 Percentage of Overriding Royalty. Under and by virtue of the Overriding Royalty hereby conveyed grantees (inclusive of that conveyed by and under the June 30th Partial Royalty Deed), grantees shall be entitled to receive from Cortez, in the proportions of the undivided ownership of each as set forth in paragraph 2.2, above,

3.1(a) Gold and/or Silver: The Royalty Base applicable to gold or silver produced from the Subject Property, other than gold or silver contained in ores or concentrate which are subject to 3.1(b), below, shall be the "Gross Value", calculated as hereinbelow specified, whether produced by in situ or solution mining, by mining ores and the extraction of gold or silver by means of heap or vat leaching, by milling or other extraction method and by refining to produce "Bullion". The term "Bullion", as used herein, means refined gold or silver meeting the generally

(iii) If either the London Bullion Market Association P.M. Gold Fix or the Handy & Harman silver quotations cease to be published, all such references shall be replaced with references to prices of gold or silver for immediate delivery in the most nearly comparable established market selected by grantors as published in "Metals Week" or a similar publication.

(ii) The average monthly price for silver for the month of production shall be determined by the average New York Silver Price as published daily by Handy and Harman, calculated by dividing the sum of all such prices reported for the month by the number of days for which such prices were reported.

(i) The average monthly price of gold for the month of production shall be calculated by dividing the sum of all of the prices for gold reported for the month by the London Bullion Market Association in its P.M. Gold Fixes divided by the number of days for which such prices were reported.

3.1(a)(1) Calculation of "Gross Value". "Gross Value" as used in this section 3.1(a) shall be determined by multiplying the ounces of gold and of silver contained in Bullion recovered during any calendar month, by the respective average price for gold and silver Bullion for that month, as follows:

Production shall be determined by the records pertaining thereto of gold or silver contained in Bullion recovered in each month from independent third-party refinery or refineries. The number of ounces (wherever used herein "ounces" refers to Troy ounces) of gold or silver contained in Bullion recovered in each month from as the case may be, recovered from Production by refining by an accepted commercial standards for refined gold or refined silver,

multiplying the number of ounces of silver contained in silver Bullion recovered during that month by the average monthly price for silver for such month, (as such average monthly price is determined as above provided), and the sum of those amounts shall constitute the Gross Value Royalty Base for calculation of gold/silver overriding Royalty applicable to this section 3.1(a) due for that month.

3.1(a)(3) Right to Take in Kind. Either of the grantees may

elect to receive its gold/silver overriding Royalty in kind by physical delivery of gold and/or silver Bullion for any calendar year, by notifying Cortez of its election on or before December 1 in the preceding calendar year. An election by either grantee to receive its overriding Royalty in kind shall be irrevocable for the calendar year for which it is made. Failure of a grantee to notify Cortez by December 1 of its election to take its overriding Royalty in kind, shall be deemed a waiver by it of all rights to take its overriding Royalty in kind during the following calendar year. If a grantee elects to take in kind, the amount of Bullion delivered to it shall be equivalent to the applicable percentage of the overriding Royalty rate, as specified above multiplied by the ounces of gold and/or silver recovered from the subject Property attributable to the applicable calendar month.

3.1(b) Ore or Concentrate Sold to Smelter: The Royalty Base for

calculation of Overriding Royalty in respect to ore produced from the subject Property and/or concentrate derived from ores produced from the subject Property (other than ore principally valuable for

the uranium and/or vanadium content thereof) which are sold in an arms-length sale to a third-party smelter by Cortez shall be the Net Smelter Returns received therefrom. The term "Net Smelter Returns" means the amount actually received by Cortez from the smelter less, (i) the costs of surface transportation, inclusive of insurance, of the ores from the subject Property (in the case of ores sold in the crude state) or of the concentrates from the mill (in the case of the sale of concentrate derived from such ores) to the smelter, to the extent that such costs are paid by Cortez, (ii) the costs of smelting such ores or concentrates if paid by Cortez and (iii) any metallurgical penalties, surcharges or other charges made or imposed by the smelter to the extent the same are paid by Cortez.

3.1(c) Uranium and/or Vanadium Ore: The Royalty Base for calculation of Royalty in respect to ore principally valuable for uranium and/or vanadium which is mined and sold from the subject Property, if such ore is sold by Cortez in the crude state in an arms-length sale, shall be the Net Sales Price received by Cortez therefor. "Net Sales Price" shall mean the proceeds received by Cortez from the sale of such ore less the costs of surface transportation, including insurance, of the ore from the subject Property to the point of sale. If such ore is concentrated by Cortez, either in its own facilities or by means of tolling arrangements, or if such ores are sold other than as a result of an arms-length transaction, then the term "Net Sales Price" shall mean the prevailing price paid at the time such ore is mined for ores of

the uranium and/or vanadium content thereof) which are sold in an arms-length sale to a third-party smelter by Cortez shall be the Net Smelter Returns received therefrom. The term "Net Smelter Returns" means the amount actually received by Cortez from the smelter less, (i) the costs of surface transportation, inclusive of insurance, of the ores from the subject Property (in the case of ores sold in the crude state) or of the concentrates from the mill (in the case of the sale of concentrate derived from such ores) to the smelter, to the extent that such costs are paid by Cortez, (ii) the costs of smelting such ores or concentrates if paid by Cortez and (iii) any metallurgical penalties, surcharges or other charges made or imposed by the smelter to the extent the same are paid by Cortez.

3.1(d) Other Mineral, Substances and Ores: If Cortez should

produce and sell any minerals, substances or ores from the subject property, other than those encompassed within the provisions of subparagraphs (a) through (c) above, the Royalty Base for calculation of the overriding Royalty applicable thereto shall be the net proceeds received for such substances after deducting the cost of the transportation thereof from the subject property to the point of sale.

3.2 Effect of Imposition of Federal Royalty: Net Proceeds of

Mines Taxes: If, in the future, a royalty is imposed on, and required to be paid upon production from, mining claims by the United States of America, the amount of such royalty actually paid to the United States by Cortez may be deducted by Cortez from the applicable Royalty Base before calculation of the Royalty payable in respect to Production from claims burdened by such United States royalty. Grantees shall be responsible for payment of any Net Proceeds of Mines taxes imposed by the State of Nevada in respect to overriding Royalty paid under this correction deed.

3.3 Percentage of Royalty Rates Applicable to Pipeline Claims.

The "Pipeline Claims," as used herein, means those mining claims described in corrected Schedule II hereto attached and incorporated herein. In respect to Production from the Pipeline Claims, the total percentage of the royalty rate for calculation of the Royalty (inclusive of any royalty conveyed by and under the June 30th

Partial Royalty Deed, and not in addition thereto) shall be one and one-half percent (1.5%) until a cumulative total of 3,700,000 ounces of gold has been produced from the Pipeline Claims by Cortez or June 1, 2083, whichever first occurs. After the earlier of June 1, 2083, or the time 3,700,000 ounces of gold have been produced from the Pipeline Claims by Cortez, the total percentage royalty rate, inclusive of any royalty conveyed to grantees by and under the June 30th Partial Royalty Deed, applicable to the Pipeline Claims shall be one percent (1%) and the additional one-half percent (0.5%) shall revert to grantors.

3.4 Committing of Ores. Prior to the earlier of June 1, 2083,

or the time Cortez shall have produced a cumulative total of 3,700,000 ounces of gold from the Pipeline Claims, Cortez shall not commingle Production derived from other portions of the Areas of Interest with Production derived from the Pipeline Claims, and, at no time, shall Cortez commingle ores, minerals or materials produced from properties outside of the Areas of Interest (as such Areas of Interest are defined in Section 4.2 below) with Production derived from properties within the Areas of Interest, except and unless all such commingled ores, minerals and material comprising Production from each source have first been weighed or measured, sampled, assayed and metallurgically analyzed in accordance with sound mining and metallurgical practice in order that the overriding Royalty due grantees hereunder can be reasonably and accurately determined. Upon request to Cortez, either grantors or grantees, or both of them, shall have the right to have a

representative present at the time all such samples and measurements are taken. Grantor and/or grantees shall have the right to obtain sample splits for separate assaying in order to determine the accuracy of the assays of Cortez. Cortez shall make available to grantors and/or grantees pertinent technical data and records within its possession reasonably required to determine the accuracy of calculation made by Cortez of overriding Royalty payable upon commingled ores, minerals or materials.

3.5 Furnishing Marketing Information. Cortez shall supply grantees monthly with duplicate settlement sheets from any refinery, mill, smelter or other purchaser of production derived from the Subject Property, whether or not the mine products have been sold, and grantees shall be supplied with Cortez' monthly reports of mining, milling and leaching activities and sufficient information as to the amounts of the gold and silver contained in dore and Bullion recovered during the month so that grantees will be able to determine the amount of production on which overriding Royalty is due grantees.

3.6 Payment of Royalty. Payments of Royalty shall be made to grantees by Cortez by check or wire transfer, at the election of grantees.

IV.

Subject Property

4.1 Properties and Interests Presently Owned or Held by Cortez. The mining claims, properties and interests therein presently owned

or held by Cortez which are subject to the overriding Royalty and rights and interests conveyed to grantees under this correction deed, are specifically listed and described on corrected schedules I and II, hereto attached and incorporated herein by this reference for all purposes. The portion of the claims referred to as the "Pipeline Claims" in paragraph 3.3, above, are listed and described in corrected Schedule II, hereto and identified therein as the "Pipeline Claims." The area encompassed within the exterior peripheral boundary of the Pipeline Claims is referred to, below, as the "Pipeline Area." If any of the Pipeline Claims are amended, relocated, patented, or if any new claims or properties or interests therein granting mining rights to Cortez are obtained by Cortez prior to June 1, 2083, within the Pipeline Area, such amended, relocated, patented, new claims, properties or interests therein shall be subject to the overriding Royalty and rights and interests granted grantees hereunder and shall continue to be denominated as a part of the "Pipeline Claims" in respect to the provisions of paragraph 3.3, above.

4.2 Areas of Interest. If Cortez should amend, relocate or patent any of the mining claims which are or which may become subject to this Correction Deed, or if prior to June 1, 2083, Cortez should locate any new claims or otherwise acquire any mineral interests granting mining rights to Cortez within any of the hereinafter described areas (the "Areas of Interest"), any such amended, relocated or patented claim or newly acquired mineral interest shall be considered for all purposes, to be a part of the

Subject Property, subject to all of the terms and conditions of this Correction Deed, including the obligation of Cortez to pay grantees the Royalty thereon as specified in Article III hereof.

4.3 Effect of Loss of Gold Fields' Claims. The mining claims

listed in Part III.(x) of corrected schedule I and in Section A of corrected schedule II hereto, record title to which is held by Gold Fields Mining Company ("Gold Fields") subject to the rights and interests of grantors under a Prospecting Permit and Option to Purchase Agreement dated August 13, 1991 between Gold Fields and PDS (the "Option") are referred to in this paragraph 4.3 as the "Gold Fields claims." Although PDS has notified Gold Fields of exercise of the Option and tendered the balance of the purchase price for the Gold Fields claims, Gold Fields has not, as yet, accepted the payment and litigation is now pending in which Gold Fields may seek to contest PDS's right to acquire the Gold Fields claims. Notwithstanding any provision to the contrary herein contained, if PDS and/or Cortez is unable to acquire the right to mine the Gold Field claims, such claims shall be excluded from the Subject Property, the Pipeline Claims and the Pipeline Area and shall not be subject to the Royalty and other rights and interest conveyed to Grantees under this Correction Deed.

Right of First Refusal

5.1 Grant of Right of First Refusal. Except as provided in

Section 5.2 below, if, prior to June 1, 2083, either of the grantees should elect to sell all or a portion of its rights and interest in the subject property and has received an offer therefor from a third party (which may be conditioned upon the performance of usual and customary "due diligence" by the offering third party), the selling grantee shall first offer the interest to be sold to Cortez by written notice specifying the name of the prospective purchaser, the portion of the interest to be sold and the price (which in any event must be a monetary amount) and the terms of payment of the purchase price. Within 30 days of the date of said notice, Cortez may notify the selling grantee of Cortez' election to purchase the offered interest at a price equal to the price and payment terms offered by the offering third party. If Cortez fails, within the said 30-day period, to agree to purchase the interest offered, then at the end of the period the selling grantee may proceed with the sale to the offering third party at the price and in accordance with the terms contained in the said notice given to Cortez, provided that the closing of the sale to the third party shall be made within 120 days of the end of the 30-day period specified above, or the sale shall become void and Cortez' first refusal rights shall be reinstated. If Cortez agrees to purchase the offered interest, in the manner above provided, a

closing of the sale to Cortez shall be held within 30 days thereafter.

5.2 Circumstances Excluded From Right of First Refusal. The right of refusal granted by paragraph 5.1, above, shall not apply to nor restrict any of the following:

(a) The mortgaging or encumbering of a grantee's interest as collateral for loans nor to a foreclosure sale which might result therefrom;

(b) Transfers by a grantee to a corporation or partnership in which the grantee owns a majority of the issued stock or in which the grantee is a general partner; and

(c) Transfers made to PDUS and/or Kennecott.

Transferees under this Section 5.2 shall be subject to the provisions of Section 5.1.

VI.

Miscellaneous

6.1 Limitations Under Rule Against Perpetuities. The rights conferred and the obligations imposed by Section 5.1, above, shall terminate twenty-one (21) years after the death of the survivor of

W.L. Wilson, Joan B. Wilson, and their presently living children, Suzanne Kelly Wilson, William Brent Wilson, Juliet Ross Wilson and Hollis Carolyn Wilson.
