2. On the 12th day of September, 1993, at 0:00 am, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the Kim Chee # 4597 Lode Mining Claim (hereafter referred to as the "Claim".)

3. The Claim is located in Eureka County, Nevada, in the UNKNOWN Mining District and is situated within the following quarter section(s), Section(s), Township(s), and Range(s) of the Mount Diablo Meridian:

SE 1/4 of Section 2, Township 21 North, Range 50 East	NE 1/4 of Section 11, Township 21 North, Range 50 East	SW 1/4 of Section 2, Township 21 North, Range 50 East	SE 1/4 of Section 11, Township 21 North, Range 50 East
SW 1/4 of Section 2, Township 21 North, Range 50 East	NE 1/4 of Section 11, Township 21 North, Range 50 East	SW 1/4 of Section 11, Township 21 North, Range 50 East	SE 1/4 of Section 2, Township 21 North, Range 50 East

4. The general course of the lode or vein, as near as may be determined, is: N 13 W and S 13 E.

5. The locator claims 1500 feet in length along the course of the lode or vein, 50 feet in a N 13 W direction and 1450 feet in a S 13 E direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the lode or vein.

6. The Monument of Location is 9947.84 in a S 58-09-23 E direction from a readily identifiable landmark, being the Section Corner common to Sections 33 and 34 T22N R50E and Sections 3 and 4 T21N R50E of the Mount Diablo Meridian which is a Marked Stone in its original position.

7. The position of each corner of the Claim is shown on the Mining Claim Map recorded herewith. The number, position, and markings on each corner monument are as follows:

8. As erected on the ground, the Monument of Location and each corner monument consist of a wooden post 1.5 inches by 1.5 inches in width by 4 feet in length; set one foot in the ground and marked as described above.

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of the making and recording of duplicate Claim maps filed herewith and incorporated hereby by reference.
