9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of the making and recording of duplicate Claim maps filed herewith and incorporated hereby by reference.

8. As erected on the ground, the Monument of Location and each corner monument consist of a wooden post 1.5 inches by 1.5 inches in width by 4 feet in length, set one foot in the ground and marked as described above.

6. The Monument of Location is 8354.34 in a N 83-21-23 E direction from a readily identifiable landmark, being the Section Corner common to Sections 33 and 34 122N R50E and Sections 3 and 4 121N R50E of the Mount Diablo Meridian which is a Marked Stone in its original position.

5. The locator claims 1500 feet in length along the course of the lode or vein, 50 feet in a S 13 E direction and 1450 feet in a N 13 W direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the lode or vein.
