 The undersigned certifies as follows:

2. On the 16th day of September, 1993, at 2:40 pm, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the Kim Chee # 5487 Lode Mining Claim (hereafter referred to as the "Claim").

3. The claim is located in Eureka County, Nevada, in the UNKNOWN Mining District and is situated within the following quarter section(s), Section(s), Township(s), and Range(s) of the Mount Diablo Meridian:

NW 1/4 of Section 25,	Township 22 North,	Range 50 East
SW 1/4 of Section 25,	Township 22 North,	Range 50 East
NE 1/4 of Section 25,	Township 22 North,	Range 50 East
SE 1/4 of Section 25,	Township 22 North,	Range 50 East

4. The general course of the lode or vein, as near as may be determined, is: N 13 W and S 13 E.

5. The locator claims 1500 feet in length along the course of the lode or vein, 50 feet in a S 13 E direction and 1450 feet in a N 13 W direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the lode or vein.

6. The monument of location is 14082.80 in a N 56-02-53 E direction from a readily identifiable landmark, being the: Section Corner common to Sections 33 and 34 122N R50E and Sections 3 and 4 121N R50E of the Mount Diablo Meridian which is a Marked Stone in its original position.

7. The position of each corner of the claim is shown on the Mining Claim Map recorded herewith. The number, position, and markings on each corner monument are as follows:
