CERTIFICATE OF LOCATION

The undersigned certifies as follows: 1. The name and address of the locator is: Cominco American Resources Incorporated 831 East Glendale Avenue Sparks, Nevada 89431

2. On the 14th day of September, 1993, at 5:05 pm, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the Kim Chee # 5493 Lode Mining Claim (hereafter referred to as the "Claim").

3. The claim is located in Eureka County, Nevada, in the UNKNOWN Mining District and is situated within the following quarter section(s), section(s), Township(s), and Range(s) of the Mount Diablo Meridian: NW 1/4 of Section 26, Township 22 North, Range 50 East NE 1/4 of Section 26, Township 22 North, Range 50 East SE 1/4 of Section 26, Township 22 North, Range 50 East SW 1/4 of Section 26, Township 22 North, Range 50 East

4. The general course of the lode or vein, as near as may be determined, is: N 13 W and S 13 E.

5. The locator claims 1500 feet in length along the course of the lode or vein, 50 feet in a S 13 E direction and 1450 feet in a N 13 W direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the lode or vein.

6. The monument of location is 10811.60 in a N 49-03-50 E direction from a readily identifiable landmark, being the Section Corner common to Sections 33 and 34 122N R50E and Sections 3 and 4 121N R50E of the Mount Diablo Meridian which is a Marked Stone in its original position.

7. The position of each corner of the claim is shown on the Mining Claim Map recorded herewith. The number, and markings on each corner monument are as follows: MARKINGS ON ALUMINUM TAGS ARE: POSITION No. 1 NW KC 5493 The NW Corner The NE Corner No. 2 NE KC 5493 The SE Corner No. 3 SE KC 5493 The SW Corner No. 4 SW KC 5493 The SW Corner

8. As erected on the ground, the Monument of Location and each corner monument consist of a wooden post 1.5 inches by 1.5 inches in width by 4 feet in length, set one foot in the ground and marked as described above.

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of the making and recording of duplicate claim maps filed herewith and incorporated hereby by reference.
