CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the SL 22 Lode Mining Claim on this 16th day of November, 1993, situated in the unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW)NW(NE) (Quarter) Section(s) 11(12)13(14), Township 22 North Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

- Then, 600 feet in a South direction to Post No. 2, marked - SE Cor SL 22
- Then, 1500 feet in a West direction to Post No. 3, marked - SW Cor SL 22
- Then, 600 feet in a North direction to Post No. 4, marked - NW Cor SL 22
- Then, 1500 feet in a East direction to Post No. 1, marked - NE Cor SL 22

Beginning at the northeast corner post No. 1,

the point of beginning and all posts being 2" x 2" x 4" Wood Posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1480 feet in a West direction and 20 feet in a East direction, together with 200 feet on each side of the center of the vein or lode for the entire length of the claim.
