CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the

lode mining claim this 12th day of November, 1993 under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

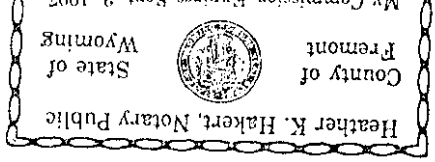
