CERTIFICATE OF LOCATION
LODE CLAIM

The Undersigned certifies as follows:

1. The name and mailing address of the locator is Frank Witzel, as an agent for LAC Minerals (USA), Inc., whose address is 1395 Greg St., Suite 107, Sparks, NV. 89431.

2. On the 21st day of October, 1993, pursuant to the mining laws of the United States and the State of Nevada, the locator located and claimed, and hereby locates and claims, the lode mining claim called the GARDEN No. 40 mining claim (the "Claim").

3. The Claim is located in an unknown Mining District, Eureka County, Nevada, in the following quarter section(s).

Quarter Section	NE ¼ and SE ¼, S. 13
Township	T. 25N.
Range	R. 48E.

4. The general course of the lode or vein is North and South.

5. The locator claims 20 feet in a Southerly direction and 1480 feet in a Northerly direction from the Discovery Monument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

6. The Discovery Monument is approximately S. 47° 35' 16" E. and 5930 feet from a readily identifiable landmark which is: The common corner of Sections 11, 12, 13, and 14 T. 25N., R. 48E., M. D. B. & M.

7. The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

8. As erected on the ground, each corner monument consists of a wooden post at least 2"x2"x4, and marked as described above with a 7/8" by 3" Aluminum tag.

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of making and recording of duplicate claim maps filed herein and incorporated by reference.
