The claim is 1500 feet long and 600 feet wide, and 250 feet is claimed in a Northernly direction and 750 feet in a Southernly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the Northernly to the Southernly.

Corner No. 4 is a 4x4x4 1/2 FT wooden post marked NW on surprise 6

Corner No. 5 is a 4x4x4 1/2 FT wooden post marked ESE surprise 6

Corner No. 6 is a 4x4x4 1/2 FT wooden post marked WSW surprise 6

The monumentation and marking of the corners was completed by the 11th day of Oct, 1993.
