The claim is 1500 feet long and 1000 feet wide, and 1480 feet is claimed in a southerly direction and 20 feet in a northwesterly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the southerly to the northwesterly.

- Corner No. 6 is a 4" x 11/2" x 11/2" wood post marked S.E. cor Supris # 9

The monumentation and marking of the corners was completed by the llc day of Oct, 1993.
