The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.

The monumentation and marking of the exterior boundaries of this claim was completed by the 25th day of October, 1993.

The exterior boundaries of this claim are clearly marked by wood posts, firmly set 1 foot in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, South 600 feet to the Southeast Corner, a 1 1/2" x 4' in length wood post,

thence, West 1500 feet to the Southwest Corner, a 1 1/2" x 4' in length wood post,

thence, North 600 feet to the Northwest Corner, a 1 1/2" x 4' in length wood post,

thence, East 1500 feet to the Northeast Corner, a 1 1/2" x 4' in length wood post,

The general course of the lode or vein is East and West.
