CERTIFICATE OF LOCATION
LODE CLAIM

The undersigned hereby certifies that he has caused to be located the MP # 6 lode mining claim on the 25th day of October, 1993.

To tie this claim to the Public Survey, begin at the NE corner of Section 33, Township 24 North, Range 48 East, Mount Diablo Base and Meridian, thence 1800 feet North and 1500 feet West to the Northeast corner of this claim.

The general course of the lode or vein is East and West.
We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 10 feet from the location monument in a Easterly direction and 1490 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by wood posts, firmly set 1 foot in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast corner:

thence, South 600 feet to the Southeast Corner, a 1 1/2" x 4' in length wood post, thence, West 1500 feet to the Southwest Corner, a 1 1/2" x 4' in length wood post, thence, North 600 feet to the Northwest Corner, a 1 1/2" x 4' in length wood post, thence, East 1500 feet to the Northeast Corner, a 1 1/2" x 4' in length wood post, the point and place of beginning.

The monumentation and marking of the exterior boundaries of this claim was completed by the 25th day of October, 1993.
