The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.

The monumentation and marking of the exterior boundaries of this claim was completed by the 25th day of October, 1993.

The exterior boundaries of this claim are clearly marked by wood posts, firmly set 1 foot in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, South 600 feet to the Southeast Corner, a 1 1/2" x 4' in length wood post, thence, West 1500 feet to the Southwest Corner, a 1 1/2" x 4' in length wood post, thence, North 600 feet to the Northwest Corner, a 1 1/2" x 4' in length wood post, thence, East 1500 feet to the Northeast Corner, a 1 1/2" x 4' in length wood post, the point and place of beginning.

The general course of the lode or vein is East and West.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Easterly direction and 10 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
