The claim is approximately 1500 feet long and 600 feet wide, such that 1480 feet is claimed in a EAST direction and 20 feet in a WEST direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location.
The general course of the lode or vein is from the EAST to the WEST direction.
The number, location and markings on each corner monument are as follows:

- No. 1 Northwest corner is a 2"x2"x4' wood post.
- No. 2 Northeast corner is a 2"x2"x4' wood post.
- No. 3 Southeast corner is a 2"x2"x4' wood post.
- No. 4 Southwest corner is a 2"x2"x4' wood post.

As erected on the ground, each corner monument is marked by the claim name, number and which corner it is with an aluminum tag attached to the post. Monumentation of this claim was completed by the 5th day of January, 1994.
This claim is intended to cover all land open to location existing within its boundaries as of this date of location.
The work of location consisted of making a claim map as provided in NRS 517.040.
