

AMENDMENTS TO CERTIFICATES OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

PETER W. LACZAY, authorized agent for SUMMIT SILVER, INC. states that the following common error was made on each of the CORTEZ lode mining claims listed below:

All of the following Cortez claims were located in the West 1/2 Section 34; Township 28 North; Range 48 East with the exception of Cortez 244 which is in the SE 1/4 of Section 33; Township 28 North; Range 48 East.

For Example:

All of these claims extend approximately 1500' southerly from their northerly end line, however, due to a typing error the certificate of location showed this distance to be 1550'.

Thence	due West	600	feet to the	Northwest	corner;
Thence	due South	1500	feet to the	Southwest	corner;
Thence	due East	300	feet to the	South	end center.
