Mount Diablo Base Line and Meridian, Eureka County, Nevada.

To tie this claim to the public survey, begin at the NW corner of section 28 T. 25 N., R. 49 E., MD Base Line and Meridian and travel:

4000 feet N 65 E
and
3900 feet N 25 W
to the northeast corner of the claim.

The claim is 1500 feet long and 600 feet wide, such that 1450 feet is claimed in a N 65 E direction and 50 feet is claimed in a S 65 W direction from the location monument, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the claim is Northeast to Southwest.

The boundaries of this claim are monumented with 2 inch by 2 inch by 4 foot long wooden posts. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim.

The corner monuments were erected within 60 days of the notice of location. To locate the monuments, begin at the northeast corner of the claim and travel:

600 feet S 25 E to the southeast corner, thence
1500 feet S 65 W to the southwest corner, thence
600 feet N 25 W to the northwest corner, thence
1500 feet N 65 E to the northeast corner of the claim.

The location work included the making of a claim map as provided in NRS 517.040, a copy of which is filed with the county recorder.
