

LIMITED POWER OF ATTORNEY

The undersigned gives to said attorney-in-fact full power and authority to execute such instruments as if the undersigned were personally present, hereby ratifying and confirming all that said attorney-in-fact shall lawfully do or cause to be done by authority hereof.

This limited power of attorney has been executed and is effective as of the 02nd day of November, 1993 and the same shall continue in full force and effect until the occurrence of any of the following events or until revoked in writing by the undersigned:

- (1) the suspension or termination of the attorney-in-fact as a Seller or Servicer of mortgages to FHLMC,
- (2) the transfer of servicing from the attorney-in-fact to another Servicer for cause,
- (3) the appointment of a receiver or conservator with respect to the business of the attorney-in-fact, or

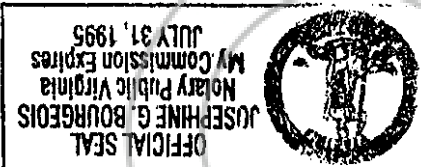
