The claim is 600 feet long and 250 feet wide, and 250 feet is claimed in a North direction and 250 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Painted with Dark Brown Paint

- Corner No. 1 is a 4" Dia Round Plastic Pipe, 5' high scribed with dirt

- Corner No. 4 is a 4" Dia Round Plastic Pipe, 5' high scribed with dirt
- Corner No. 5 is a 4" Dia Round Plastic Pipe, 5' high scribed with dirt
- Corner No. 6 is a 4" Dia Round Plastic Pipe, 5' high scribed with dirt

The monumentation and marking of the corners was completed by the 50 day of April, 1994

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Curk County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
