

RESOLUTION

WHEREAS, the Board of County Commissioners of Eureka County, State of Nevada, held a Public Hearing pursuant to Nevada Revised Statutes of its intention to vacate streets in the Town of Eureka, County of Eureka, State of Nevada, more particularly described as follows:

All those certain street as shown on the map titled PLAT OF THE TOWNSITE OF EUREKA, NEVADA; filed in the Office of the County Recorder of Eureka County, Nevada on June 20, 1989, described as follows:

All of Bell Street adjacent to Blocks 84 and 85.

All of Treasure Street from the West line of Blocks 88 and 87 to the center line of Bell Street and the South 1/2 of Treasure Street from the center line of Bell Street to the East line of Block 67.

All of Pit Street from the West line of Blocks 86 and 87 to the East line of Lot 5 in Block 121 and the North 1/2 of Pit Street from the East line of said Lot 5 to the East line of Block 67.

All of Capron Street from the North line of Blocks 85 and 88 to 60 feet South and parallel to the South line of Pit Street.

All of the public right-of-way shown 18.3 feet wide between Lots A, and B in Block 88.

WHEREAS, at the time and place set for said Public Hearing, and no persons having appeared to object to the proposed vacation, and the said Board having deemed it for the best interests of the public that said streets be vacated; and

WHEREAS, it appearing to the satisfaction of the said Board that the streets are no longer required for public use and convenience and that the vacation thereof will inure to the benefit of the Town of Eureka, County of Eureka, State of Nevada, and that neither the public or any person will be materially injured thereby.
