CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the WS 271 Lode Mining Claim on this 25th day of March, 1994, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE (Quarter) Section 5, Township 22 North, Range 49 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner Post No. 1,

Thence, 600 feet in a S 02° E direction to Post No. 2, marked - WS 271 - 2  
Thence, 1500 feet in a S 88° W direction to Post No. 3, marked - WS 271 - 3  
Thence, 600 feet in a N 02° W direction to Post No. 4, marked - WS 271 - 4  
Thence, 1500 feet in a N 88° E direction to Post No. 1, marked - WS 271 - 1

the point of beginning and all posts being 2" X 2" X 4' wood posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 88° E direction and 10 feet in a S 88° W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 88° E and S 88° W.

To tie this Claim to the Public Survey, begin at the Southeast corner, Section 16, Township 22 North, Range 49 East, Mt. Diablo P.M., and bear S 88° W, 5829 feet and N 02° W, 14799 feet to the northeast corner of this Claim.

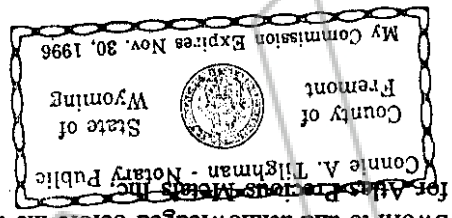
