The general course of the lode or vein is from the northwesterly to the southeasterly direction.



No. 3: Southeast Corner	COR. NO. 3 (SE COR.) MOLE 13	4" X 4" X 4" wood post
No. 4: Southwest Corner	COR. NO. 4 (SW COR.) MOLE 13	4" X 4" X 4" wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag.

The work of location consisted of making a claim map as provided in N.R.S. 517.040 which map is recorded herewith.
