NOW, THEREFORE, in consideration of the premises, the payment of Ten Dollars (\$10.00) by Sublessee to Sublessor, and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, and for the purpose of amending said sublease, it is now and hereby agreed, notwithstanding anything to the contrary in said sublease as originally executed or as amended by any previous amendments, that:

In Article 2 of said Sublease, line 2, the date, the 15th of May, 1991, shall be changed to read the 1st day of August, 1991.

Sublessor acknowledges that said sublease, as amended, is valid and in full force and effect and for such purpose Sublessor hereby grants, leases and lets to Sublessee all of Sublessor's interest in the above described lands upon the same terms, conditions and provisions as are contained in said sublease as amended hereby and by any amendment heretofore executed. This agreement and amendment shall be binding upon and inure to the benefit of the parties hereto, their successors, personal representatives and assigns.

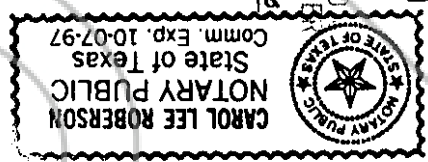
