

CERTIFICATE OF LOCATION
LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that Battle Mountain Exploration Company, a Texas corporation, whose address is 2700 E. Executive Drive, Suite 150, Tucson, Arizona 85706, did on this 18th day of March, 1994, locate and claim and does hereby locate and claim, in compliance with all applicable law and regulation, the RM #9 Lode mining claim. The lode mining claim is approximately 1500 feet long and 600 feet wide, such that 1490 feet are claimed in a westerly direction and 10 feet in an easterly direction from the point of discovery (monument of location), at which the Notice of Location/Certificate of location was posted, together with 300 feet on each side of the monument of location and center line of the lode mining claim. The general course of the lode or vein is from the East to the West direction.

The location of each monument is shown on the lode mining claim map recorded herewith. The position and markings of each monument are as follows:

Position/Markings

- Monument No. 1 is a post marked Discovery Monument
- Monument No. 2 is a post marked Northeast corner
- Monument No. 3 is a post marked Northwest corner
- Monument No. 4 is a post marked Southwest corner
- Monument No. 5 is a post marked Southeast corner

All monuments consist of a wooden post at least 1.5" in diameter and 4' in length set at least one foot in the ground and marked as described above on an aluminum tag or on the post. The monumentation and marking of the above-described lode mining claim was completed within 60 days from the date of posting the Notice of Location/Certificate of Location pursuant to NRS 517.030, as amended.

The work of location consisted of making and recording of duplicate lode mining claim maps and payment of fees prescribed by NRS 517.040 as amended. Said lode mining claim map and description have been filed with the County Recorder's office and the Nevada State BLM office and are by reference incorporated herein.
