CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY THAT, in accordance with the requirements of Title 30, United States Code, Section 28, and the local laws, customs, and regulations of this state, the I-126 Lode Mining claim was located by Carl Pascio on the 14th day of April, 1994.

The claim is 1500 feet long and 600 feet wide, and 10 feet is claimed in a Northwesterly direction and 1490 feet in a Southeasterly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center line of the claim. The general course of the lode deposit and premises is from the Northwest to the Southeast.

The claim is located in the surveyed/protracted SE 1/4 Section 10, SW 1/4 Section 11 and NW 1/4 Section 14

Township 17 North, Range 53 East, Mount Diablo Meridian, Unknown Mining District, Eureka County, State of Nevada, and is more particularly described by metes and bounds as follows:

Beginning at Corner No. 1 which is the Northeast corner of this mining claim, thence S 20° E a distance of 1500 feet to Corner No. 2 which is the Southeast corner of this mining claim; thence S 70° W a distance of 600 feet to Corner No. 3 which is the Southwest corner of this mining claim; thence N 20° W a distance of 1500 feet to Corner No. 4 which is the Northwest corner of this mining claim; thence N 70° E a distance of 600 feet to Corner No. 1, the point of beginning.

Claim boundaries are monumented by wooden posts at least 1 1/2 inches in diameter by 4 feet in length set one foot in the ground, one at each corner of the claim. Each corner contains markings sufficient to appropriately designate it as a corner of said claim.

Beginning at Corner No. 4 which is the Northwest corner of this claim, thence 10, 124' North and 10, 646' East to the following natural object or permanent monument, to wit: The Northwest Corner, Section 6, Township 17N, Range 54E, Mount Diablo Meridian, State of Nevada.

The work of location consisted of making a claim map as provided in N.R.S. 517.040, as amended 1985.
