
3. The Owner intends to hold the claims for the assessment year ending on September 1, 1995.

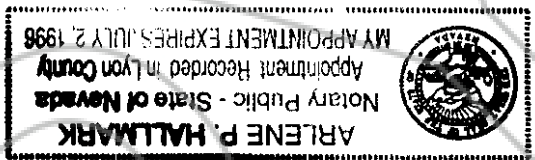

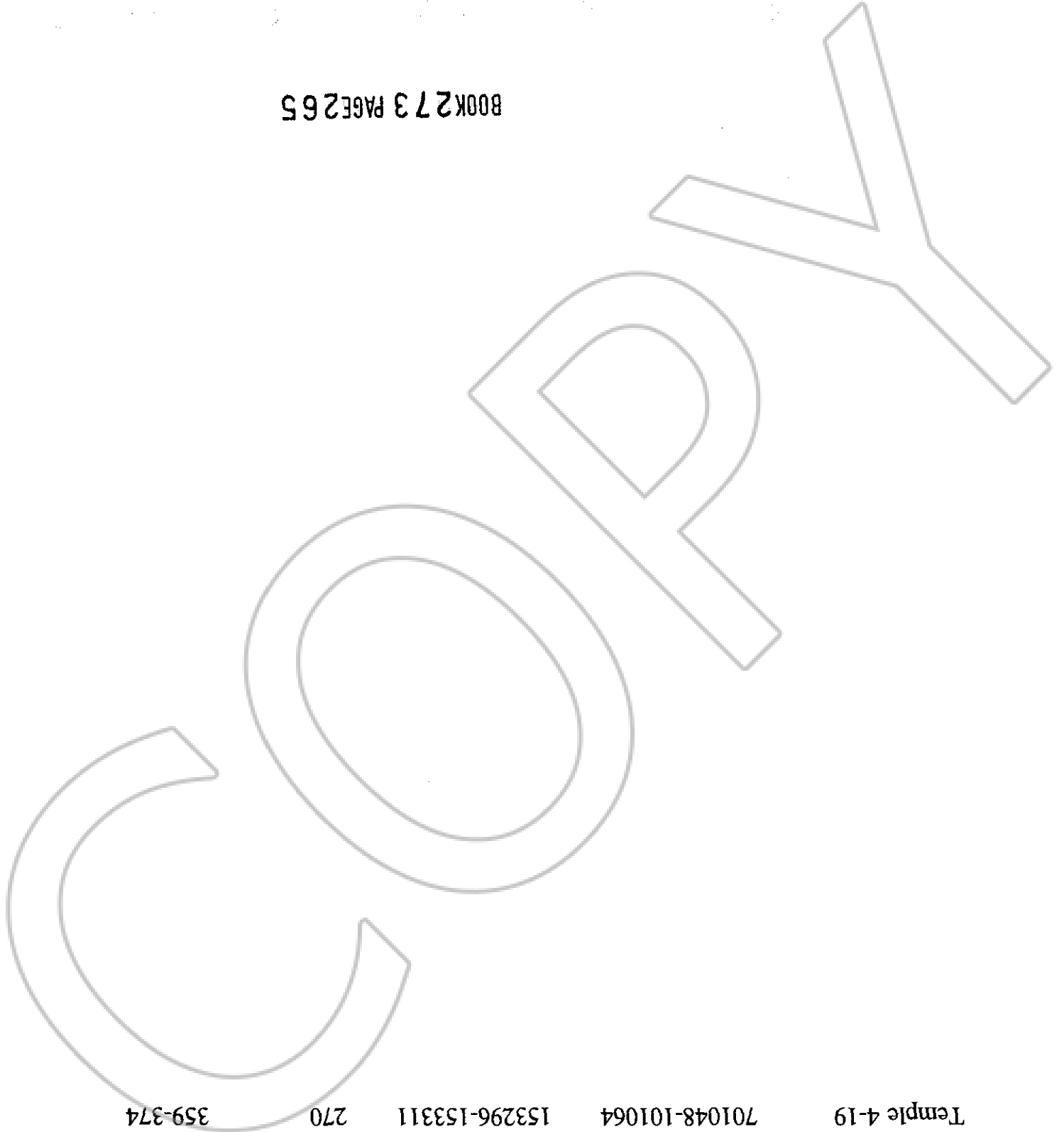
