- On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada; the undersigned located and claimed the lode mining claim called the <u>FC-72</u> Lode Mining Claim (the "Claim").

- 4. The general course of the lode or vein, as near as may be determined is north and south.
