The undersigned certifies as follows:

1. The name and address of the Locator is:

- On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the FC-76 Lode Mining Claim (the "Claim").
- 3. The Claim is located in <u>Eureka County, Nevada</u>, in the <u>Fish Creek Mining District</u> approximately within the following quarter section(s), Section(s), Township(s), and Range(s), Mount Diablo Meridian:

- 4. The general course of the lode or vein, as near as may be determined is north and south.
