CERTIFICATE OF LOCATION

The undersigned certifies as follows:

1. The name and address of the Locator is:

2. On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the FC-81 Lode Mining Claim (the "Claim").

3. The Claim is located in Eureka County, Nevada, in the Fish Creek Mining District approximately within the following quarter section(s), Section(s), Township(s), and Range(s), Mount Diablo Meridian:

SW ¼ of Section 17, Township 16 North, Range 53 East  
SE ¼ of Section 18, Township 16 North, Range 53 East  
NE ¼ of Section 19, Township 16 North, Range 53 East  
NW ¼ of Section 20, Township 16 North, Range 53 East

4. The general course of the lode or vein, as near as may be determined is north and south.

5. The locator claims 1500 feet in length along the course of the vein or lode, 1490 feet in a south direction and 20 feet in a north direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

6. The monument of location is approximately 400 feet in a N13°E direction from a readily identifiable landmark, being the unsurveyed common corner of sections 17, 18, 19, 20, T.16 N. R.53 E., Mount Diablo Meridian.

7. The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number and position of each corner of the Claim is marked on an aluminum tag attached to each corner monument, more particularly described as follows:

Beginning at the NE Corner (No. 1), thence 1500 feet to the SE Corner (No. 2), thence 600 feet to the SW Corner (No. 3), thence 1500 feet to the NW Corner (No. 4), thence 600 feet to the Point of Beginning.

8. As erected on the ground, the monument of location and each corner monument consist of a wooden post at least 1.5 inches by 1.5 inches in width by 4 feet in length, set one foot in the ground and marked as described above.

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of the making and recording of duplicate claim maps filed herewith and incorporated herein by reference.

10. Certain clerical deficiencies in the Notice of Location were corrected on August 9, 1994.
