- On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the <u>FC-83</u> Lode Mining Claim (the "Claim").
- The Claim is located in <u>Eureka County, Nevada</u>, in the <u>Fish Creek Mining District</u> approximately within the following quarter section(s), Section(s), Township(s), and Range(s), Mount Diablo Meridian:
