- On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the FC-91 Lode Mining Claim (the "Claim").
- The Claim is located in <u>Eureka County, Nevada</u>, in the <u>Fish Creek Mining District</u> approximately within the following quarter section(s), Section(s), Township(s), and Range(s), Mount Diable Meridian:

- 4. The general course of the lode or vein, as near as may be determined is north and south.
- 8. The locator claims 1500 feet in length along the course of the vein or lode, 1480 feet in a south direction and 20 feet in a north direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.
