- The Claim is located in Eureka County, Nevada, in the Fish Creek Mining District approximately ithin the following quarter section(s), Section(s), Township(s), and Range(s), Mount Diablo Maridian:

- The general course of the lode or vein, as near as may be determined is north and south.
- The locator claims 1500 feet in length along the course of the vein or lode, 1480 feet in a north rection and 20 feet in a south direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.
