## CERTIFICATE OF LOCATION

The undersigned certifies as follows:

1. The name and address of the Locator is:

- On the 19th day of July, 1994, pursuant to and in compliance with the mining laws of the
  United States and the State of Nevada, the undersigned located and claimed the lode mining

- 4. The general course of the lode or vein, as near as may be determined is north and south.
- 5. The locator claims 1500 feet in length along the course of the vein or lode, 1480 feet in a north direction and 20 feet in a south direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.
- The monument of location is approximately 2700 feet in a S13°E direction from a readily identifiable landmark, being the unsurveyed common corner of sections 17, 18, 19, 20, T.16 N. R.53 E., Mount Diablo Meridian.
- 7. The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number and position of each corner of the Claim is marked on an aluminum tag attached to each corner monument, more particularly described as follows:
