CERTIFICATE OF LOCATION

The undersigned certifies as follows:

1. The name and address of the Locator is:

2. On the 12th day of August, 1994, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the GRAY-47 Lode Mining Claim (the "Claim").

3. The Claim is located in Eureka County, Nevada, in an unknown mining district approximately within the following unsurveyed and unprotracted quarter section(s), Section(s), Township(s), and Range(s), Mount Diablo Meridian:

NE 1/4 of Section 9,	Township 17 North, Range 53 East
SE 1/4 of Section 9,	Township 17 North, Range 53 East
NW 1/4 of Section 10,	Township 17 North, Range 53 East
SW 1/4 of Section 10,	Township 17 North, Range 53 East

4. The general course of the lode or vein, as near as may be determined is N20°W and S20°E.

5. The locator claims 1500 feet in length along the course of the vein or lode, 1480 feet in a N20°W direction and 20 feet in a S20°E direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.

6. The monument of location is approximately 4540 feet in a N43°W direction from a readily identifiable landmark, being Hill 6738 located in the NE 1/4 of Section 15, T.17 N., R.53 E., Mount Diablo Meridian.

7. The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number and position of each corner of the Claim is marked on an aluminum tag attached to each corner monument, more particularly described as follows:

Beginning at the NE Corner (No. 1), thence 1500 feet to the SE Corner (No. 2), thence 600 feet to the SW Corner (No. 3), thence 1500 feet to the NW Corner (No. 4), thence 600 feet to the Point of Beginning.

8. As erected on the ground, the monument of location and each corner monument consist of a wooden post at least 1.5 inches by 1.5 inches in width by 4 feet in length, set one foot in the ground and marked as described above.

9. The monumentation and marking of the monuments on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of the making and recording of duplicate claim maps filed herewith and incorporated herein by reference.
