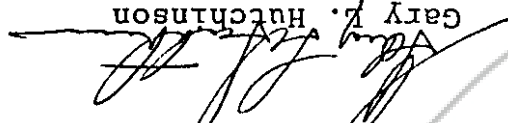
To the Bureau of Land Management:
