1. This Affidavit is made pursuant to the provisions of The Interior Department and Related Agencies Appropriations Act of 1993, Public Law 102-381 of October 5, 1992, 106 Stat. 1374, 1378-79, as well as Section 3 of A.B. 422, an amendment to the laws of the State of Nevada dated March 29, 1993.

Euro-Nevada Mining Corporation, Inc., a Nevada corporation and Franco-Nevada Mining Corporation, Inc., a Nevada corporation, Suite 240, 6121 Lakeside Drive, Reno, Nevada 89511, are the owners ("Owner") of the unpatented mining claims ("Claims") more particularly described in Exhibit A attached hereto and by this reference incorporated herein. 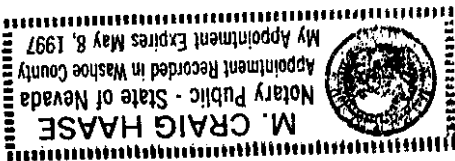
