

NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That LAWSON MECHANICAL CONTRACTORS, a California

corporation, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.221,

et seq., laws of the State of Nevada, after deducting all just credits and offsets, in the

amount of ONE MILLION FIVE HUNDRED FORTY THREE THOUSAND SEVEN

HUNDRED FORTY FIVE DOLLARS (\$1,543,745.00), on the real property and

improvements located at the Newmont Gold Company Refractory Ore Treatment Plant

Site and the facilities approximately six miles north of the City of Carlin, in Eureka

County, Nevada, generally located in Townships 33 and 34 North and Ranges 50 and 51

East.

2. The name of the owner or reputed owner of the above described

property is Newmont Gold Company, whose address is six miles north of Carlin, Nevada.

3. LAWSON MECHANICAL CONTRACTORS provided work and

improvements on the above real property and improvements pursuant to a contract with

Fletcher Industrial, Inc. of Seattle, Washington. Upon information and belief, the general

contract under which all work was performed is identified as Contract #21777-RP.

4. This lien is claimed for material and labor for work performed on the

property and improvements described in paragraph 1, above. Said work consisted

principally of design, fabrication and installation of the dust collection duct work and

stacks for the Refractory Ore Treatment Plant on the Newmont Gold Company project.

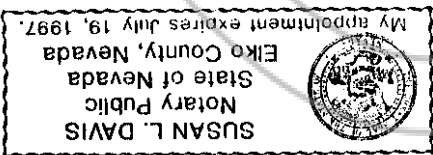
